## to Consider Pre and Post Your Immigration Arrival to The UK

The government estimates that up to 322,000 HK citizens will gradually take up the BNO Visa offer over the next five years and relocate to the UK. Coincidentally, if you so happen to be one of these trailblazers (pat on the back), paving the way for your later counterparts, or even just considering immigration as an alternative to your current lifestyle, then here is an important checklist for you to consider pre and post your arrival to the UK.

### PERMANENT ADDRESS



Applying for leases may be met with all sorts of complications as a foreigner. In many cases, Proof of Income, Credit Reference Check are needed. We do encourage securing a permanent address pre-arrival so that large amounts of funds will not be expended on Airbnb or hotels. Permanent address is also needed to apply for necessary services. Check if the property you want to rent out is registered with official agencies and the properties Ombudsman.

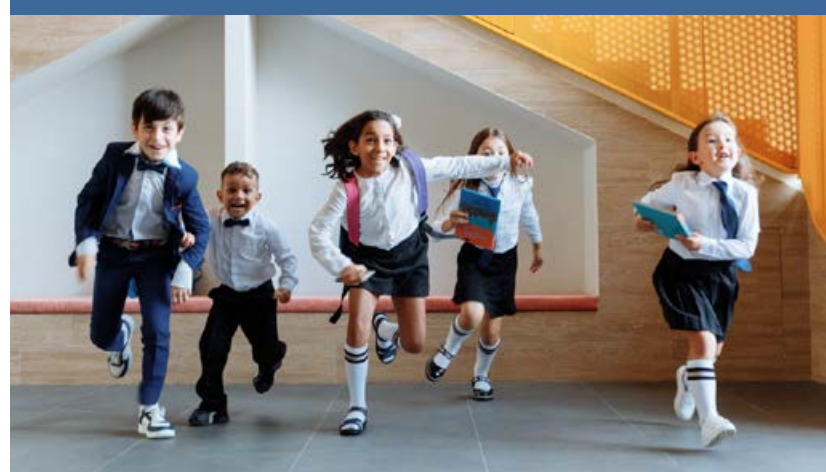

### LOCATION SCOUTING

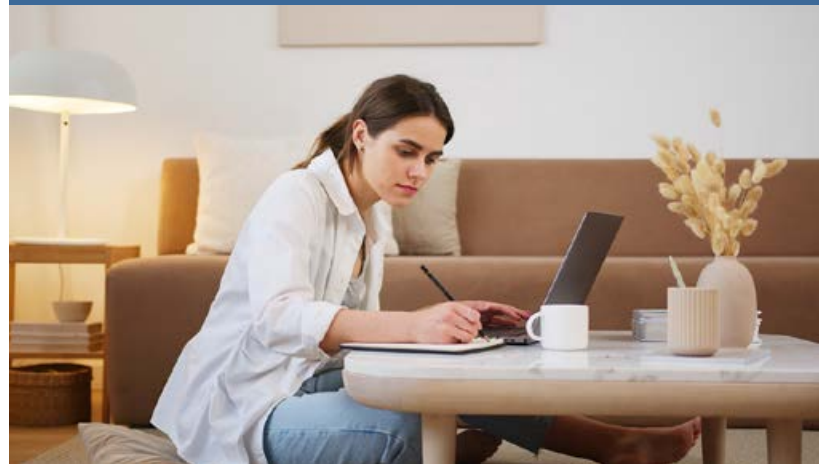


Things to look out for when scouting for location:

- Rich school network
- Close proximity to Asian markets if you know you will be missing food from Hong Kong.
- Close proximity to relatives for appropriate support if needed.

### PROOF OF RESIDENCY

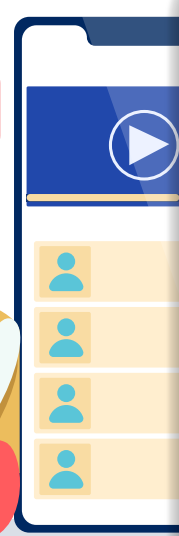


You may attain it from achieving a permanent address

- Council tax payments
- Water, Gas/Electric bills
- Proof of residency can then be used to apply for different services
- Bank Account
- Primary and Secondary School Placement
- General Practice (Family Doctor available through NHS)
