With this in mind, out of all the perks and benefits offered by the UK government, we have selected a few practical ones for your information. Hopefully, these tips will come in handy for your immigration needs.

### Perks for BNO Visa Holders

#### Universal 15 Hour Entitlement : Beneficiary - Parents and Children of Age 3-4

- Regardless of immigration status, all 3-4 year olds living in England are eligible for 570 hours per year of free childcare service
  - The 570 hours can be delivered:
    - Over a minimum of 38 weeks (15 hours a week)
    - Stretched over up to 52 weeks
    - During school holidays and weekends
  - Contact your "Approved" childcare provider or local council to find out more
    - "Approved" childcare provider includes but not limited to
      - Registered childminder, nanny, nursery
      - Childcare agency
      - Registered school



#### Free Education : Beneficiary - Students of age 5-18

- Free education provided by state-funded schools
  - State schools
  - Grammar Schools

### Free Dental Services



- Dental services are free for individuals below the age of 18, individuals below 19 years old in full-time education, and pregnant individuals or has had a baby in the last 12 months
- Free orthodontics treatments
  - NHS orthodontic treatment is free for people under the age of 18 with a clear health need for treatment.
  - High demand, there can be a long waiting list

### Universal Credit

- Monthly credit
  - For low income and unemployed individuals

### Pension Credit

- Weekly top up credit
  - For individuals who are above state pension age (currently 66), low income, low savings
- If you are single, and your weekly income does not exceed approximately £177, then your pension credit will top up your weekly income to this amount
- If you are partnered, and your weekly income does not exceed approximately £270, then your pension credit will top up your weekly income to this amount
- Qualified pension credit candidates also become eligible for other benefits
  - TV license - £160/ year
  - Discounted council tax
  - Warm home discount - £140 in energy credit form
  - Cold weather payments - £25/ week when temperature hits below 0 degrees Celsius

Please note that all of these perks and benefits are not automatic. They require official applications. For more information, please contact your local council.

  - 570小時可分開
    - 最少38個星期（每星期最多15小時）
    - 最多52個星期
    - 在學校假期和週末期間
  - 詳情可查詢已註冊的托兒機構或當地市政府
    - 認可托兒機構包括但不限於：
      - 註冊保姆
      - 註冊托兒中心
      - 註冊學校

- 英國政府推行義務教育，提供13年免費教育
  - 公立學校 State School
  - 文法學校 Grammar School

## 退休金補助 (Pension Credit)

- 每周發放補貼
  - 惠及年過退休年齡 66歲、低收入、低資產人士
- 如你單身，而每周入息不多於£177，可領取該項入息補貼，以填補不足的數額
- 如你有伴侶，而每周入息不多於£270，可領取該項入息補貼，以填補不足的數額。
- 合資格申請退休金補助亦同時合資格申請其他資助，如：

- 電視牌照費扣減（一年扣減£160）
- 市政府稅扣減
- 暖氣折扣計劃（一季扣減£140）
- 寒冬天氣補貼（如每星期溫度低於攝氏零度即補貼£25）
